OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

OPEN ONLY TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND DISTRICT OF COLUMBIA, WHO ARE 18 YEARS OF AGE OR OLDER (OR THE AGE OF MAJORITY IN THEIR STATE/JURISDICTION OF LEGAL RESIDENCE) WHICHEVER IS OLDER AT TIME OF ENTRY. INTERNET ACCESS REQUIRED. STANDARD DATA CHARGES MAY APPLY.

1. SWEEPSTAKES PERIOD: Lavazza Organic Cold Brew "Win a Trip to Italy" Sweepstakes (the "Sweepstakes") begins June 3, 2022 at 10:00AM Eastern Time ("ET") and ends September 30, 2022 at 5:00PM. ET (the "Sweepstakes Period").

ELIGIBILITY: Open to legal residents of the 50 United States and the District of Columbia who are 18 years of age or older (or the age of majority in their state/jurisdiction of legal residence, whichever is older) as of date of Entry. HOW TO ENTER VIA FACEBOOK: Between June 13, 2022 and July 3, 2022 or August 22, 2022 and September 18, 2022, log in to Facebook (or create a free account at [www.facebook.com](http://www.facebook.com) if you do not already have one), and visit <https://www.facebook.com/LavazzaUSA>. You may enter by clicking on the Facebook Post link and follow the instructions to complete and submit the Facebook entry form ("FB Entry"), to be entered into the Sweepstakes.

Collectively, Website Entries and FB Entries will be referred to as "Entries". Limit one Entry per person, regardless of method of Entry. Any attempt by any entrant to obtain more than the stated number of Entries by using multiple/different email addresses, identities, registrations, or any other methods will void that entrant's Entries and that entrant may be disqualified. By entering, you agree that you are solely responsible for all internet access and data charges that you incur. All such charges are billed by and payable to your internet or mobile service provider. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JUDICIAL ARBITRATION AND MEDIATION SERVICES, INC., IN ACCORDANCE WITH ITS STREAMLINED ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN NEW YORK. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE ANY DISPUTE WILL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO CLASS ACTION.
